Services

Our spring service check is included for maximum air conditioning efficiency. It may be performed in conjunction with a heating system tune-up. All labor charges included for covered repairs during normal working hours. A charge of 1/2 our normal labor rate per hour will apply to all after-hours service.

Compressor still under manufacturers' parts warranty replaced with no labor charge. 10% discount toward compressor failures out of warranty. Discount applies to compressor, refrigerant, dryers, labor and any miscellaneous parts. No charge for use of refrigerant recovery equipment on compressor replacement or refrigerant leak repairs.

General Conditions

- 1) A spring service check will be performed once during the term of this agreement... This check includes: Cleaning condenser coil, Lubricate blower and condenser motors, etc.
2) Labor is covered only for the repair and replacement of listed parts during normal working hours.
3) We are not responsible for replacement parts that are obsolete or not obtainable.
4) We reserve the right to inspect and approve the equipment covered before accepting the service agreement.
5) This agreement covers one domestic air conditioning unit. It does not apply to window units, wall units or units 25 years or older.
6) Exclusions: This agreement does not cover parts or labor due to: Failure to check for open switches, Tripped circuit breakers, etc.
7) This agreement is void if all fuel requirements or service on any parts or equipment covered by this plan are purchased from any source other than Norbert E. Mitchell Co., Inc.
8) This agreement does not cover, nor does it create, liability or damages resulting from failure of the equipment or consequential damages resulting in delays or inability to supply parts caused by or resulting from any cause not within our control, or at unattended dwellings.
9) There are no promises, terms, conditions or obligations other than those printed herein, and this agreement contains the entire agreement of the parties hereto.
10) Your account must be current to be covered by this service agreement.
11) The length of this agreement is one year. It will automatically renew at that time unless we are notified of cancellation in writing thirty (30) days prior.
12) If the customer is in violation of any of the terms of this agreement at any time, Norbert E. Mitchell Co., Inc. may terminate this agreement, without refund.

Service Hours

During the life of this agreement, Norbert E. Mitchell Co., Inc. will provide dependable, prompt emergency service 24 hours a day, 7 Days a week, 365 days a year. Emergency service is available after normal working hours for the following: NO COOLING OR SERIOUS WATER LEAKS. All other regular service will be performed during normal working hours, Monday through Friday, 7 a.m. to 5 p.m., except Holidays.
