Services

Our annual service check is included for maximum air conditioning efficiency. It may be performed in conjunction with a heating system tune-up.

All labor charges included for covered repairs during normal working hours. A charge of 1/2 our normal labor rate per hour will apply to all after-hours service.

10% discount toward compressor failures. Discount applies to compressor, refrigerant, dryers, labor and any miscellaneous parts.

No charge for use of refrigerant recovery equipment on compressor replacement or refrigerant leak repairs.

General Conditions

- An annual service check will be performed once during the term of this agreement, during regular working hours. It is your responsibility to arrange an appointment for this important service. Your right to this service check expires at the end of each coverage year. We will issue no credit if not performed nor will we carry over this right to any subsequent year. This check includes:

- Labor is covered only for the repair and replacement of covered parts during normal working hours. A charge of 1/2 our normal labor rate per hour will apply to all after-hours service.
- We are not responsible for replacement parts that are obsolete or not obtainable. Parts upgrades are not covered and will be charged accordingly.
- We reserve the right to inspect and approve the equipment covered before accepting the service agreement. Initial repairs required to put the air conditioning system in acceptable condition are not covered.
- This agreement covers one domestic air conditioning unit. It does not apply to window units, wall units or units 25 years or older.
- Exclusions:** This agreement does not cover parts or labor due to:

- This agreement does not cover, nor does it create, liability or damages resulting from failure of the equipment or consequential damages resulting in delays or inability to supply parts caused by or resulting from any cause not within our control, or at unattended dwellings.
- There are no promises, terms, conditions or obligations other than those printed herein, and this agreement contains the entire agreement of the parties hereto.
- Your account must be current to be covered by this service agreement.
- The length of this agreement is one year. It will automatically renew at that time unless we are notified of cancellation in writing thirty (30) days prior.
- If the customer is in violation of any of the terms of this agreement at any time, Norbert E. Mitchell Co., Inc. may terminate this agreement, without refund.

Service Hours

During the life of this agreement, Norbert E. Mitchell Co., Inc. will provide dependable, prompt emergency service 24 hours a day, 7 Days a week, 365 days a year.
